



- The Executive Office will check and give the permission after receiving the documents by the certificated construction company which is registered in Coex or Bexco, or the documents by the participants,


Booth Layout

The participation Rules of Jinju International Agriculture & Food Expo 2016

[Article 1] Definition of terms

- 1, 'participant' means a company, association, organization or person who handed in the participation application form and paid the booth fee.
- 'Expo' means Jinju International Agriculture & Food Expo 2016.
- 'Host' means Jinju City Hall, Gyeongnam Province,

[Article 2] Participation application

- 1. Participants must hand in the application form to the host after filling out the form and pay the booth fee notified after the arrangement of the booth,
- In case of any changes in the proposed documents, participants must inform host of the changes and will take all the responsibility for the disadvantage caused by withholding informing the changes,

[Article 3] Arrangement of Exhibition Space

Host must consider the participants' nationality, the exhibit items, the reception order, applied exhibition space, booth type and participants location when arranging the location of booth, Participants must cooperate with the demands of the host,

(Article 4) Management of Exhibition Hall

- Participants must exhibit only the items indicated in the application form and arrange staff who will manage the booth.
- In case that participants exhibit items which are not indicated in the application form or which are not suitable in this expo, or they try to sell the items directly without advance permission, the host can order the stopping exhibition and sales or the clearing the booth. In this case, the booth fee will not be refunded and the participants can not ask for the compensation,
- 3, Participants must not transfer, resale or exchange any part of the booth without host's written consent,
- 4. Participants must not vandalize or change floor, ceiling, pillars or walls of the booth with paints or glues(adhesives).
- Host can selectively exclude or restrict the exhibition items and exhibition to secure the maintenance of order and safety and to prevent the violation of social norms.

[Article 5] Booth Fee Payment Condition

- 1, Participants must pay the booth fee notified by the host after signing the contact,
- If the participant does not pay the participation fee and other related fees, the host can put off his participation until the participant pays the fees or can hold the exhibition items selectively.

[Article 6] Participants' Cancellation or Change in participation

- 1, If participants wants to cancel the use of some or all exhibition space, the participants must inform the host of the cancellation in the written form,
- Cancellation 20 days before the exhibition: 50% of the booth fee will be refunded.Cancellation 10 days before the exhibition: 20% of the booth fee will be refunded.
- 3, Other fee except the refund will be confiscated and there will be no interest on the confiscated money.

[Article 7] Cancellation or Change in Expo

If the Expo is stopped or cancelled due to the exhibition, the booth fee will be calculated by the used days and refunded, In case of natural disastersor uncontrollable situation, the booth fee will be fully refunded,

[Article 8] Installation and Exhibition of the items

Participants must complete the installation and exhibition of the items within the allocated period,

[Article 9] Taking the items and equipment out of the booth

Participants must take the items and equipment out of the booth within the allocated period, and if they do not complete it, they must pay the additional charge which the host will cover for the delay,

[Article 10] Exhibition Security, Risk Bearing and Insurance

- Host will take suitable safety measures for the participants and visitors,
- Participants will take responsibility of the damage and theft of the equipment and exhibit items in the arranged booth during the exhibition and removal of the booth.
- If the participant intentionally or mistakenly causes damages or hurts to the host or other participants by a fire, theft, breakdown or others, he will take responsibility of the compensation and the insurance for the damages,

[Article 11] Fire Prevention Rule

All the materials used in the booth must be nonflammable, abiding by the Fire Prevention Regulations and the host can ask the participants to remedy the installation to prevent a fire,

[Article 12] Protection of Intellectual Property Rights

Participants must not exhibit the products or technology which can infringe other's patents or intellectual property rights, if the participants do not abide by this rule, the host will ask the participants to withdraw from the exhibition and will not refund the exhibition-related charges,

[Article 13] Supplement Rules

If needed, the host can enact the supplement rules which are not indicated in the participation contract, and the participants must abide by the added supplement rules,

(Article 14) Solution of Conflict

The conflict on the participation rules between the host and the participant and the conflict on both parties' right and duty will be solved through the mutual discussion. If both parties do not get the solution through the mutual discussion, both parties will follow the result of mediation of the competent court and can not appeal the result,
